

## Archstone Foundation Announces \$914,384 in New Grants

Long Beach, CA, March 17, 2015 – The Board of Directors of Archstone Foundation, a grantmaking foundation committed to preparing society in meeting the needs of an aging population, approved 14 grants, totaling \$914,384, during the third quarter of fiscal year 2015.

The following grants were awarded and fell into the following categories:

### *Aging in Community*

- **Center for Oral Health**, Pomona, California (\$150,000): A two-year grant to document the dental care needs of older adults in California, inform policy and decision makers about the needs of underserved older adults, and to advocate for changes in institutional and public health policies that improve oral health care services and health outcomes for older adults in California.
- **Community Partners**, Los Angeles, California (\$80,000): A two-year grant to support the annual Senior and Policymaker Education Summit in Sacramento, California. The Summit seeks to raise the visibility of the need for innovative aging in community models and programs.
- **Galilee Center**, Mecca, California (\$50,000): A one-year grant to support and expand the Senior Emergency Services Program, a program that provides basic services to reduce poverty and homelessness in the Eastern Coachella Valley.
- **Project Angel Food**, Hollywood, California (\$50,000): A one-year grant to support a Medically Tailored Meals for Seniors program, a program distinguished by the ongoing involvement of healthcare professionals in managing clients served.
- **Travelers Aid Society of San Diego, Inc.**, San Diego, California (\$59,788): A two-year grant to support the continuation of the SenioRide Program, a transportation program for low-income adults, age 60 and above.
- **University of California, Berkeley**, Berkeley, California (\$116,496): An 18-month grant to assess the impact of California Villages and to develop the evidence needed by policymakers and potential funding partners.

### *Communications*

- **Tides Center**, San Francisco, California (\$75,000): A one-year grant to the California Health Report to provide in-depth and accessible information, about aging in community, depression in late-life, caregiver support, and workforce development.

### *End-of-Life & Palliative Care*

- **Pathways Volunteer Hospice**, Lakewood, California (\$50,000): A one-year grant to support the Pathways Life Legacy Program (PLL), a program that allows hospice participants to communicate their stories, experiences, and values to their descendents and loved ones.
- **Coalition for Compassionate Care of California**, Sacramento, California (\$10,000): A one-year grant to support the 7th Annual Palliative Care Summit & Conference, “Palliative Care: A Call to Action,” in Sacramento on April 14-15, 2015.

*Workforce Development*

- **The American Academy of HIV Medicine**, Washington, District of Columbia (\$50,000): A one-year grant to support the third phase of the HIV and Aging Consensus Project, and to continue to raise the level of understanding of HIV and aging issues.
- **California Council on Gerontology & Geriatrics**, Los Angeles, California (\$10,000): A one-year grant to support the 35<sup>th</sup> Annual Education Meeting, entitled, *The Faces of Aging: California Stories*, in Long Beach, California on April 10, 2015.

*Responsive Grantmaking—Other*

- **Grantmakers In Health**, Washington, District of Columbia (\$113,100): A two-year grant to support Grantmakers In Health (GIH) and Grantmakers In Aging (GIA), national affinity groups for health and aging funders, to foster communication and collaboration among health and aging grantmakers, strengthen their knowledge, skills and effectiveness, and contribute to developing solutions around family caregiving, aging in community, workforce development and depression in late-life.
- **Legal Services for Seniors**, Seaside, California (\$50,000): A one-year grant to support the Legal Services for Seniors – Legal Outreach project, which provides legal support to older adults in Monterey County, California.
- **Providence Speech and Hearing Center**, Orange, California (\$50,000): A one-year grant to support the Hear For All Program for Older Adults, a program designed to reduce social isolation and other negative health implications related to hearing loss among older adults.
